

Official Contest Rules & Regulations

The following rules and regulations (“Official Rules”) govern the **JoeAnna’s House Winter Wonderland Wishlist Contest** (the “Contest”), sponsored by the **Kelowna General Hospital Foundation** (“KGH Foundation”), located at **321 Royal Ave, Kelowna, BC, V1Y 0G4**. Participation in the Contest constitutes full and unconditional agreement to these Official Rules.

1. Contest Period

The Contest begins on **November 20, 2025, at 12:00 a.m. Pacific Time (“PT”)** and ends on **December 20, 2025, at 12:00 p.m. (noon) PT** (the “Contest Period”). The winner will be selected by random draw on **December 20, 2025, at approximately 4:30 p.m. PT**.

2. Eligibility

The Contest is open to residents of **British Columbia** who are **19 years of age or older** at the time of entry. Employees, contractors, and board members of the **KGH Foundation** and their immediate families are not eligible to participate.

3. How to Enter

There are **two (2) ways** to enter the Contest:

1. **Participate** in any Winter Wonderland Wishlist initiative hosted by participating local businesses between November 20 and December 20, 2025, and complete the official entry form available at <https://joeannashouse.com/winter-wonderland-wish-list/>
2. **No purchase necessary:** Write a **500-word essay** explaining “*Why JoeAnna’s House is important to our community*” and mail it to:

Mailed entries must be **received by 12:00 p.m. (noon) PT on December 20, 2025**.

All entries, including those received by mail, will have an **equal chance of winning**. Limit of **one (1) entry per person**.

4. Prize

There is **one (1) prize** available to be won consisting of:

One (1) WestJet Gift of Flight voucher valid for one (1) roundtrip flight for two (2) guests to any regularly scheduled and marketed WestJet destination.

(No cash value. Taxes, fees, and surcharges not included. Blackout dates and restrictions apply.)

The prize must be accepted as awarded, is **non-transferable**, and has **no cash value**.

Fees, taxes, and surcharges are the responsibility of the winner and must be paid at the time of booking.

Bookings and travel must be completed by **November 20, 2026**.

5. Winner Selection and Notification

A **random draw** will be conducted by the KGH Foundation on **December 20, 2025**, at approximately **4:30 p.m. PT**.

The **odds of winning** depend on the total number of eligible entries received during the Contest Period.

The selected entrant will be **notified by phone and/or email**.

The selected entrant must correctly answer a **mathematical skill-testing question** without assistance and must respond within **five (5) business days** of notification to claim the prize.

Failure to do so will result in disqualification, and an **alternate winner may be selected**.

6. General Conditions

The KGH Foundation reserves the right to **cancel, modify, or suspend** the Contest should any cause beyond its control affect the administration, security, or proper conduct of the Contest. All decisions of the KGH Foundation are **final and binding** in all matters relating to the Contest.

By participating, entrants agree to abide by these Official Rules and **release the KGH Foundation and WestJet** from any liability arising from participation or prize use.

7. Privacy

Personal information collected for this Contest will be used **solely for the administration** of the Contest and in accordance with applicable privacy laws.
